Present at the table were Vice-Chairman McGurn, Selectman Brazie. Vice-Chairman McGurn chaired the meeting in the absence of Chairman Turner.

Others in attendance: Corey Wiley(Berkshire Record), Liz Keene, Sara Love, Peter Goldberg, Logan Malik.

Pledge of allegiance was recited.

It was announced that the meeting is video and audio recorded.

MINUTES:

The minutes of the December 18, 2017 were accepted as presented.

SCHEDULED ISSUES:

The Board interviewed Sara Love for a vacancy on the Agricultural Commission. The Board voted unanimously to appoint Sara to the Commission.

The Board interviewed Logan Malik for a vacancy on the Conservation Commission. The Board voted unanimously to appoint Logan to the Commission.

NEW BUSINESS:

The Board approved an amendment to the Cell Phone Use policy so the policy covers all town buildings not just Town Hall.

John Andrews Restaurant did not renew its liquor license. Until such time as they have an approved license their policy will be BYOB.

A March/April Special Town Meeting may be held to approve amendments to the Zoning Bylaws.

FOLLOW UPS:

Vice-Chairman McGurn updated the meeting as to the status of Charter/Spectrum broadband and cable franchise license. Charter has not fully responded to the requests of the town so negotiations are in a holding pattern. Still to get details on are the build out time line, cost of installation beyond 250', cost of installation of underground service, price of PEG, and coverage area. Peter Goldberg was particularly interested in coverage to private roads with underground service. The town needs to inform Charter that it wants service to all town buildings; Town Hall, the two Fire Stations, Library, South School, Water Plant, Police Station and Highway Department. Depending on the what happens in the future the South Egremont Church may be included.

SELECTMEN'S ITEMS:

The next regular board meeting will take place on Monday, January 22, 2018.

Vice-Chairman McGurn reported that the next meeting of the shared services group will be on Thursday, January 19 at 6:30pm at the Egremont Town Hall. He would like the public to be made aware.

BUDGET/TOWN MEETING:

The Board will hold budget review meetings on Wednesday, January 17 and Monday, January 29.
